SECRETARY/TREASURER:

Betty Figels reported on the 3 quotes received for a new dump truck. Each would be at a cost of over \$100,000.00+ and council decided to table proceeding with the idea, at this time.

Betty Figels reported two quotes received for a roller and a snowblower attachments to the new skid steer. Council was opposed to the roller until talking to Jeremy on its possible uses. The snow blower will be considered and reach out for grants.

Betty Figels is still working with a company for final quote on the new "Welcome to Turbotville" sign. It was decided that the 5 x 9 sign would be the better size.

STREETS/HIGHWAY:

Council received a conditional use request from Susquehanna Solar LLC.
